8. Ten Minutes representation by the public Swanton Street Footpath

Swanton Street Footpath

There are two possible routes for a potential footpath for Swanton Street residents leading into the village. Each route would impact on local landowners' land. KCC proposed an elaborate pathway with tarmac and railings etc. however, this was felt to be unnecessary and a simple track would suffice and be less costly. Enquiries are to be made with the landowner by a member of the public.

11. Reports from Councillors

A check with BT on the progress of Broadband for the village confirmed that it was on track for delivery in mid-summer. KCC and BT are currently agreeing a new procurement schedule which will be updated on the BT website in June.

The allotments in Silver Street are all taken now, any further enquiries for a plot will go on a waiting list.

The pond remains generally healthy. Chris Logden is to replant reeds, which were eaten by ducks.

The pest control contract has ended and Cllr. Priestley along with Cllr. Clack will continue to bait the traps and monitor the rats. It may be necessary to purchase some new traps.

Councillors agreed to a working party to tidy up the planting around the pond alongside the road on 20th June at 10am.

The Village Hall Committee has held their AGM and all is well. The Chairman, Andy Dwyer, has agreed to continue in the post for one more year.

An overgrown tree in the cemetery has been chopped back.

Cllr. Mr. G. Kite

Rats have become a problem in Silver Street; Cllr. Kite is to contact the Drainage Board to try to resolve the issue as the rats are in the drains.

The footpath sign at the top of Deans Hill, which was bent over, has been removed. Tree roots along Travers Walkway are lifting the path. Councillors are unsure who owns the path; Cllr. Clack offered to investigate.

12. Clerk Committee

Blind Marys Lane

Cllr. Bonney confirmed that MKP are currently considering the validity of the 'schemes' proposed by occupants of the Brazil site, in relation to the conditions attaching to their temporary planning permission. The High Court decision in relation to the Baker site provides that occupation must cease by 23rd May, with the caravan removed by 23rd July.

The PC suggested contacting MP Gordon Henderson with a view to requesting a further conversation with Central Government concerning Gypsy/Traveller policies and planning matters.

Lime Kiln Road

The site was visited today by SBC planning officers. An application is expected imminently.

Dukes Shaw

Planning officers visited the site today; the application is going to Committee in June /July.

Primrose House

All issues have been resolved between the owners and SBC.

16. Update on reopening of Bredgar Post Office and Fun Day

The reopening of the Post Office following the ram raid is on track for 23rd May. A Fun Day is planned for Saturday 27th June to reward customers for their patience. The PC resolved to request a reimbursement of rent paid whilst the Post Office has been out of service. A letter will be sent to the owner of the Farmshop.
